

## Ozark Trail Association 2020 Fourth Quarter Board Meeting Zoom Online Conference Saturday, November 21, 2020

A meeting of the directors of the corporation was held on Saturday, November 21, 2020, at 10:30 A.M., via Zoom Conferencing Service, for the purpose of reviewing the prior year's business, discussing corporate operations for the upcoming year, and for the transaction of any other business that may properly come before the meeting, pursuant to notice and in accordance with Bylaws of the Ozark Trail Association, A Missouri Nonprofit Corporation.

Ms. Abi Jackson was elected Chairman of the meeting and Mr. Jeff Goetter was appointed Secretary thereof.

The secretary announced that the meeting was held pursuant to notice, if and as required under the bylaws of this corporation.

The secretary announced that the minutes of the 3<sup>rd</sup> Quarter Board meeting held on August 29, 2020 were provided at the meeting. After discussion, a vote was taken, and the minutes of the meeting were approved by the directors in attendance.

The first item of business was the opportunity for open public discussion by meeting attendees.

The next item of business was the **President** report from Ms. Kathie Brennan. Please see **Attachment 1** for the submitted report. Ms. Brennan discussed the Great America Outdoors act and possible thread restoration project and the issues on the Blair Creek section and the off-road vehicle problems, as a result a meeting was set with the USFS to discuss ways to remediate the off-road use issues. Ms. Brennan feels this was a productive meeting. New MOU needed with ONSR and AmeriCorps.

The next item of business was the **Vice President** report. Ms. Brennan passed on they are still waiting for input from the Department of Conversation on the Meramec Blue Trail.

The next item of business was the **Treasurer's** report by Mr. Roger Alison. The 2019 990 Tax form was completed and submitted for review. Discussion was held about the need

to look closer at the document to ensure it best reflects us and that it will provide useful information to any grant provider who may review it.

The next item of business was the **Chief Operations Officer** report by Ms. Abi Jackson, please see **Attachment 2** for the report.

The next item of business was reports from the Standing Committees.

The **Communications Committee** was reported on by multiple individuals. Mr. Garret Doak reported the website team is working on updating the site plugins, once the plugins are updated work can start on the list of 52 enhancements and fixes to the website. See **Attachment 3** for full report.

The **Construction & Maintenance Committee** report was presented by Mr. Terry Hawn. Even though a good portion o the year was shut down there were a lot of events, including mid-week events that took place. Kudos to all the people who have gone out on the trail during the COVID-19 period doing maintenance and scouting. Ms. Brennan also did kudos for the prep workers for the different races. Weekday events have been a great help. See **Attachment 3** for the submitted report.

The **Planning and Development Committee** was reported by Ms. Brennan. Work event will be held at Udal in December.

The **Education and Outreach Committee** was reported. No outreach events are on the books currently. See **Attachment 7** for the submitted report.

The **Finance Committee** was reported on by Mr. Garret Doak. Mentioned the corporate sponsorship and Café Press efforts are moving forward, will need some more time.

Jon Breithaupt is forming a planning committee for the Trail Skills College on the USFS side, first meeting will be first week of December. IF anyone has input for topics please pass them to Abi.

The next item of business was a call for new business.

First item discussed was the work being done toward a Vision/Value Statement presented by Ms. Joy Hayes. Ms. Hayes shared that having such a statement would allow us to apply for more grant opportunities that are currently not available to us. She is suggesting starting by drafting a survey for the group to complete gather items that would best fit this and once the draft is complete it would be reviewed and approved by the board. Ms. Brennan suggested an ad hoc committee be put together.

Next new business item was the status of the Recruiting and Nominating committee. Ms. Brennan would like assistance with the committee for recruiting, not just for the Board, but for committees. Ms. Jackson reviewed the current committee members.

The Status if the OT Guidebook was discussed. We are almost out of stock on the current edition and the need to start working on the next revision. After discussion it was decided to order more of the current version until the work gets completed.

Discussion was held on the need to assembler and\or update any documentation we have of the Landowners along the OT as part of the National Trails Recreation trail designation

update. Mr. Breithaupt shared there is a new Forest Recreation Program Manager, and he will be the contact in the USFS related to the NRT designation. There is also concern about knowing what easements may already be in effect currently on the trail and the Planning Committee will reach out to the agencies to try to determine what easements are currently be held.

After discussion, a survey will be taken to determine the date of the Annual Board Meeting, a tentative date of Saturday, January 16, 2021 was set for the Meeting.

There being no other further business before the Board, on motion duly made seconded and carried, the meeting was adjourned.

## L-A-D Grant

After applying for a grant from the L-A-D Foundation, we were awarded \$2,500 to go toward a Trail Skills College that will be held in fall of 2021. This will be very similar to the one in 2016 and a planning committee has been formed with representatives from USFS, OTA and BCHMO.


The event generated ~\$19K in revenue, with ~\$3.6K in associated expenses (just under 19%).


